The OC Ski Club provides a racing opportunity to all club members.

The OC Ski Club will fund the racing budget.

Each racer makes his/her own decision to race on any given day. Racers are urged to review the race course prior to the race.

The Ski Club contracts with a ski area to set up and maintain the race course. The Club only provides gate keepers, who determine if racers have valid run(s) on the race course in order for their score to count officials and score keepers.

All Gatekeepers, scorekeepers and officials are provided with lift tickets for working a race. The tickets are negotiated through the mountain. Not all mountains will provide tickets for these individuals. In these cases the sponsoring Club will have to cover the costs. For our Club race these costs will be part of the race budget. The race chair is also provided a lift ticket for each NYCDSC race and Club race, which should also be part of the Club race budget.

All racers **MUST** complete and sign a Club waiver of risk (see pages 17-2 and 17-3 of this Section). This waiver must be renewed for each race season. A waiver will be available at Club meetings and at Club races for new members. No Club member or guest will be allowed to participate in any race without a signed waiver on record.

All racers must sign up for the race in advance. A racer may sign up late if there is an available spot. If a racer misses a race that they have signed up for, which the Club has paid for, the racer will be requested to pay the racing fee for that race or will not be allowed to race in a NYCDSC sanctioned race with the Club until the Club is fully reimbursed for the cost.

A Club race for will be set up once a season for Club members interested in racing.

As part of the New York Capital District Ski Council the Club will pay its race fees (from the race budget) to the Council for all Council races in which the Club participates.

The racers will follow the rules set up by the New York Capital District Ski Council, which will be presented annually.

Awards will be provided as established in the New York Capital District Ski Council rules.
